You are hereby notified that it has been determined that the property described above is subject to forfeiture pursuant to MCL 333.7521, et seq. Since the total value of the seized property does not exceed \$50,000, it is the intent of the seizing agency to forfeit and dispose of the above described property according to the provision of MCL 333.7521, et seq. If you or any person wish to claim an interest in the above described property and challenge the seizure and forfeiture of the property you must file a written claim with the seizing agency at the Taylor Police Department within 20 days of the notice And you must post a bond to the Taylor Police Department in the amount of 10% of the value of the claimed property, but not less than \$250.00 or greater than \$5,000. Once a written claim and bond is posted with the Taylor Police Department the case will be referred to the Wayne County Prosecutor's Office seeking the filing of an action in the Wayne County Circuit Court. Failure to file a claim of interest and bond within 20 days shall cause the listed property to be declared forfeited and disposed of according to law.

☐ Omnibus Forfeiture

You are hereby notified that it has been determined that the property described above is subject to forfeiture pursuant to MCL 600.4701 et. Seq. You are not required to do anything further at this time to claim an interest in the seized property. This forfeiture proceeding will parallel your criminal proceedings and you and/or your attorney will be contacted by the Wayne County Prosecutors Office and/or the seizing agency.
