DETAILS:

On 08-21-13, at approximately 2:17am, Officers R. Barnosky and D. Toth were dispatched to 21230 Eureka Rd., Room 149, Taylor, MI on the report of an assault. The location was the Red Roof Inn motel.

Upon arrival, the officers spoke with Ms. Ehrlich who stated that she had received a call from her friend Brittany Bonsall advising that a Diamond Seals would be coming to the room to retrieve her belongings. A short time later Seals arrived and knocked on the door. Ehrlich observed only Seals at the door and opened it. When Ehrlich opened the door Seals, Nathaniel Manning, "Boss" and "Orlando" entered the room. Nathaniel Manning held Ehrlich down as Seals began punching her multiple times in the face. "Boss" began to videotape the assault using a camera while Reginald Walker remained outside in a vehicle. At some point all the subjects fled in a tan 2000 Chevrolet Blazer with a dealer plate. Ms. Ehrlich was observed to have a bruised right eye and small lacerations to the right side of her face.

Ms. Ehrlich told the officers that the subjects would be hanging out in the area of Marvin and Superior in Taylor. Ehrlich further told the officers that the subjects were on felony parole and carried guns.

The officers, along with others, proceeded to the area of Marvin and Superior, finding the Chevrolet Blazer parked in front of 13693 Marvin. Officer Toth knocked on the door and a subject later identified as Johnny Nettleton answered. Officer Toth asked Nettleton if he lived at the location and Nettleton said he owned the home. Officer Toth asked Nettleton if he could come in and speak with him. Nettleton said yes and advised

the officers that he had nothing to hide. As Officers Toth and Barnosky began to enter the house a black male later identified as defendant Walker attempted to shut the door on the officers. The officers proceeded into the house and Officer D. Diggs-Taylor observed a large bag of suspected crack cocaine lying on the floor in plain view and within arms length of defendant Walker. Officers J. Thivierge, J. Graves, C. Cates, C. Wietfeldt and P. Collop entered the location to assist as there were several subjects inside. All the subjects were detained and later placed under arrest for loitering in a place where drugs were sold or kept. Defendant Walker was also detained and later arrested. Officer Collop patted down defendant Walker based upon information provided by Ms. Ehrlich that he was known to carry guns. Additionally, based upon training and experience Officer Collop knew that firearms were commonly kept in close proximity to narcotics and are a tool of the drug trade. Officer Collop located 23 individually wrapped baggies of suspected crack cocaine in Walker's front right pocket as well as 12.1 grams of suspected cocaine powder. Officer Collop also recovered \$5,311 in Walkers left front pocket.

All other subjects found in the residence, with the exception of Walker, were arrested and later charged with local ordinance violations in the 23rd District Court.

Officer Diggs-Taylor recovered the bag of suspected crack cocaine from the floor where Walker had been. Discovered in the bag was a total of 48.1 grams of crack cocaine, 14.9 grams of suspected powder cocaine and 25.6 grams of a white substance believed to be used to "cut" the cocaine. Also in the bag were (16) white pills with "Watson 387" imprinted on them (suspected Hydrocodone), 45 blue pills with "20839 V" imprinted on them (suspected Alprazalam/Xanax), 7 pills with "93/48" imprinted on them (suspected Metformin) and 3.16 grams of an off-white substance believed to be heroin. In plain view on the kitchen counter was a scale and sandwich baggies. All the suspected narcotics were weighed, field tested and placed into evidence by Officer Toth. Officer Toth also placed the US Currency recovered from defendant Walker's person into evidence.

A closer inspection of the currency found on defendant Walker revealed that it consisted of (14) \$100 bills, (12) \$50 bills, (159) \$20 bills, (7) \$10 bills, (12) \$5 bills and (1) \$1 bill. Defendant Walker was served Forfeiture paperwork for the currency.

On 08-21-13, Det. S. Schwein was assigned the case for follow-up and prosecution. Det. Schwein has been a police officer with the City of Taylor for over 18 years and held the rank of detective for the past 14 years. From 1999 to 2002 Det. Schwein was assigned to a federally sponsored drug task force that concentrated on narcotics trafficking in the metro Detroit area. During that three year period, Det. Schwein was the officer in charge of a number of narcotics investigations that led to the seizure of large quantities of heroin, cocaine and marijuana. From 2002 until present, Det. Schwein has been assigned to the detective bureau and been the officer in charge of multiple narcotics cases that included delivery and simple possession. In 2007 Det. Schwein was the officer in charge of a homicide investigation that led to a search warrant executed in the City of Taylor. Defendant Walker was arrested and charged with Possession with Intent to Deliver cocaine, Felon in Possession of a Firearm and Felony Firearm in relation to that search warrant. While in the detective bureau, Det. Schwein has spoken to a number of confidential informants who provided information on defendant Walker selling crack cocaine in the Taylor area. Based upon training and experience, Det. Schwein knows the scale and sandwich baggies are commonly used to package narcotics for sale. Based upon training and experience, Det. Schwein knows that the crack cocaine individually packaged and found on defendant Walker is consistent with the sale of cocaine. Based upon training and experience, Det. Schwein knows the crack cocaine individually packaged and found near defendant Walker is consistent with the sale of cocaine. Based upon training and experience, Det. Schwein knows that the large quantity of pills, not in prescription bottles, is consistent with the sale of said

pills. Based upon training and experience, Det. Schwein knows large sums of money, in small denominations, are commonly kept in close proximity to narcotics and is indicative of the sale of drugs. A review of defendant Walker's criminal history showed him being arrested and charged with Possession with Intent to Deliver a controlled substance at least five times. LEIN also showed Walker currently on parole for a controlled substance case.

On 08-21-13, Det. G. Piche prepared a search warrant for 13693 Marvin. The search warrant was approved by APA S. Zieger and signed for execution by 23rd District Court Judge G. Salomone. Detectives with the Taylor Police Department executed the search warrant on 08-21-13. Recovered from residence was a medicine bottle of Metformin in the name of Reginald Walker, a package of razor blades, a glass pipe commonly used to smoke crack cocaine as well as residency paperwork for Johnny Nettleton. All items were located, photographed, recovered and placed into evidence by Dets. Schwein and Piche. While executing the search warrant, Dets. Schwein and Piche were approached by neighbors who reported an abundance of short stay traffic at the residence over the past few days. This short stay traffic, along with the narcotics recovered from Walker and the residence, is indicative of the sale of drugs.

LINEUP: None

ADMISSIONS/CONFESSIONS:

On 08-21-13, at approximately 10:35am, Det. Schwein read defendant Walker his Miranda Rights. Walker stated that he understood his rights. Walker denied ownership of any drugs found inside the Marvin St. address. Walker further denied having any drugs on his person at time of arrest. Walker stated that he was at the Marvin St. address visiting friends. When asked again about the cocaine found on his person and in the house, Walker stated that he would let his lawyer handle it. Explaining his source of income, Walker stated that he was an entertainment promoter but was unable to provide documentation. Walker's statements consisted mostly of the homicide investigation previously listed. The interview was preserved on DVD and Walker did not provide a written statement.
