#### Narrative:

On Wednesday August 21, 2013 at approximately 0217 hours, Ofc. Toth and I (Ofc. Barnosky) were dispatched to the Red Roof room 149 at 21230 Eureka, Taylor, MI 48180 on a female stating that she was just jumped.

Officers arrived on scene and spoke to victim Holly Rachelle Ehrlich. Ehrlich stated that she was in her room and recieved a call from Brittany Anne Bonsall stating that she was going to be sending her friend, Diamond Lachelle Seals, to get her belongings out of her hotel room.



Seals arrived at the hotel room door and knocked. Ehrlich observed only Seals at the door so she opened it to give her Bonsall's belongings.

When Ehrlich opened the door, defendant Nathaniel Marcus Manning, and unknown defendants by the name of "Boss" and "Orlando" came running into the room. Manning held down Ehrlich on the bed while Seals began to punch her multiple times in the face. I observed Ehrlich to have a bruised right eye and small lacerations onto the right side of her face. Ehrlich stated that "Boss" began to video tape the assault using a camera, while defendant Reginald Deshawn Walker stayed in the vehicle.

All defendants then took off in a tan 2000 Chevrolet Blazer with a dealer plate. I asked witness Markus Joseph Burns what he saw. Burns stated that he observed a bunch of people run into Ehrlich's room and all he heard was screaming. He then ran to the office and told the worker to call 911 and that a woman was being assaulted. By the time Burns got back out to Ehrlich's room, all defendants had taken off.

I asked Ehrlich if she has any idea where they would go and she stated that she knew that they hang out in the area of Marvin and Superior. I asked Ehrlich if she needed any medical attention and she stated that she was going to seek it on her own. Ehrlich stated that the defendants are also on felony parole and that they carry guns. Officers then left the location and proceeded to the area of Marvin and Superior.

Officers arrived at Marvin and Superior and observed the tan 2000 Chevrolet Blazer with dealer plates parked in front of 13693 Marvin. Cpl. Thivierge, Sgt. Godlewski, Cpl. Graves, Ofc. Cates, Ofc. Diggs-Taylor, Ofc. Collop, and Ofc. Wietfeldt all arrived on scene to assist.

Ofc. Toth knocked on the front door and defendant Johnny Erwin Nettleton answered the door. Ofc. Toth asked Nettleton if he lived at the location and he stated that he owns the house. Ofc. Toth asked Nettleton if he can come in to speak with him and he stated that he could and he also stated that he has nothing to hide and that we could search the whole house. As Ofc. Toth and I began to walk into the house, Walker attempted to shut the front door on officers. Ofc. Diggs-Taylor then observed a large bag of crack cocaine lying on the floor in plain view and arms length of Walker. Cpl. Thivierge, Sgt. Godlewski, Cpl. Graves, Ofc. Cates, Ofc. Collop, and Ofc. Wietfeldt all entered the house and began to order everyone to the ground. I ordered Walker to the ground, to which he complied. Walker was placed into handcuffs, tension checked/double locked, and escorted to our police vehicle by Ofc. Collop. Due to Ehrlich stating that Walker is known to carry guns, Ofc. Collop searched Walker's person. Ofc. Collop recovered 23 individually wrapped crack cocaine baggies totaling 6.27 grams in his right front pocket. Ofc. Collop also recovered \$5,311.00 in Walker's left front pocket. Walker was then placed into our patrol vehicle.

Also when officers entered the house, defendant Sheldon Len McCoy disregarded our commands and





began to walk to the rear bedroom of the house. Ofc. Diggs-Taylor, and Ofc. Cates were able to grab onto him and take him to the ground. While on the ground, McCoy still resisted the officers by refusing to place his hands behind his back. Officers were finally able to get his hands behind his back, and place him into handcuffs, tension checked/double locked.

Defendants Brittany Anne Bonsall, Diamond Lachelle Seals, Nathaniel Marcus Manning, and Alisha Ann Farrer were all placed into handcuffs; tension checked/double locked, and placed into the rear of our police vehicles. Officers then went upstairs and placed Raymond Walter Herrmann into handcuffs, tension checked/double locked, and placed him into the rear of Ofc. Cates vehicle. Ofc. Diggs-Taylor collected the narcotics from the front door.

I then went out to speak with Nettleton. Nettleton stated that we again can search the whole house and that he has nothing to hide. Officers then searched the basics of the house and recovered a scale with sandwich bags on the kitchen counter. Due to my training and experience, a scale and sandwich baggies are common tools in the use of narcotic sales.

Are Towing arrived on scene and towed the vehicle to Area Towing. The vehicle was placed on LEIN as impounded.

All defendants were transported to Taylor Police Department and turned over to Jail PSO Schnell without incident.

Due to Walkers criminal history of narcotic sales and distribution and the way the the narcotics were packages for sale, it is believed that the \$5,311.00 that Walker had on his person came from the sales of narcotics. Due to this, the money is forfeited. Ofc. Toth and I, along with Sgt. Hall counted the money three times and got a total value of \$5,311.00. (14-\$100.00, 12-\$50.00, 159-\$20.00, 7-\$10.00, 12-\$5.00, 1-\$1.00) Walker was explained the Drug Asset Forfeiture Form to which he did not sign.

When searching Manning, Ofc. Toth recovered \$246.00 in cash. Due to Mannings history of narcotic sales, the money was forfeited due to the belief that it came from narcotic sales and that he was in possession of narcotics. (1-\$100.00, 6-\$20.00, 4-\$5.00, 6-\$1.00) Manning was explained the Drug Asset Forfeiture form to which he understood and signed.

While at the station, I field tested the crack cocaine that was in Walkers pocket. It tested positive for cocaine. The first baggie was all powder and weighed 12.1 grams. The second baggie weighed 6.2 grams and had 23 individual.





The narcotics next to Walker when officers entered the residence was 16 Watsons, 7 Mettarmin, 45 Xanax, 14.16 Grams of Cocaine, 25.6 Grams of an unknown substance, 1.66 Grams of Marijuana, 3.16 Grams of Heroin, and three baggies of 163 pieces of crack cocaine. All narcotics and cash were placed into evidence locker 13.

Field Test Analysis paperwork was completed and attached.

The Drug Asset Forfeiture forms are attached.

McCoy Taylor warrant was taken out of LEIN.

Bonsall was issued citation 13TA12350 for loitering near places where controlled substances, paraphernalia are illegally kept.

McCoy was issued citation 13TA12351 for interference with police authority and loitering near places where controlled substances, paraphernalia are illegally kept.

Herrmann was issued citation 13TA12352 for loitering near places where controlled substances, paraphernalia are illegally kept.

Farrer was issued citation 13TA12353 for loitering near places where controlled substances, paraphernalia are illegally kept.
