

AFFIDAVIT OF NATHANIEL MANNING


I, Nathaniel Manning, affiant herein, swear under the penalty of perjury that the following statements are true and factual regarding the events that took place at 13693 Marvin Street, Taylor, Michigan, on 8/21/13, and thereafter. I state:

- 1) that on the above date and location, there were ten people, including myself, celebrating my release from jail.
- 2) that two of the people left before the police came, "Boss" and "Orlando."
- 3) that when I heard knocks on the door, I thought it was the two returning from the gas station.
- 4) that when the door was opened I saw the police officer, I immediately threw the drugs I had away from myself.
- 5) that the drugs I threw away was about 3 grams of powdered cocaine.
- 6) that I believe that the powdered cocaine was about 3 grams because I purchased 4 grams from "Boss" earlier, and I had used about a gram during the time I had it.
- 7) that I watched the black officer pick up the powdered cocaine that I threw and added it with the rest of the drugs he was picking up.
- 8) that I did not admit to the powdered cocaine that night because I did not know the Taylor Police were going to falsely put them on another person, especially not "Reggie" [Reginald Deshawn Walker] because he was already outside when the drugs were discovered. The police forfeited my money that night because of the drugs, so I thought they knew the drugs were mine, or at least suspected that they were mine.
- 9) that once I was informed Reggie was being charged with all of the drugs found in the house I contacted his mother and told her about my part, and the drugs that were mine. Ms. Walker told me that she would have Reggie's attorney contact me.
- 10) that after not being contacted by his attorney, I called Ms. Walker again and she told me that his attorney was not going to use my testimony. I was back in prison at the time for a parole violation and not able to go to Reggie's trial and tell my story.
- 11) that once I was released from prison I wrote an affidavit stating all the aforementioned facts, and sent it to Reggie's appellate attorney, Michael Middlestat. I was informed that he never used the affidavit, and never gave it to Reggie.
- 12) That I have been to prison twice for drug possession since the time of the aforementioned incident, and I have tried to inform everyone that I also had drugs "that night" where Reggie was convicted of the drugs I possessed.

13) that since Reggie's lawyers refused to inform the courts of my involvement with this crime, I will do so by sending copies of this affidavit to any and every court in Michigan, the prosecutor's offices, integrity units, innocence projects, and any one else I believe may help. I believe everyone should know that I possessed some of the drugs that night, that the Taylor Police forfeited my money because I possessed drugs that night, but they still charged and convicted Reggie with those drugs. His case number is 13-008885-01-FH.

I swear under the penalty of perjury that all statements herein are true to the best of my knowledge, understanding, recollection, and belief, and I am willing to testify to my statements herein.
